New Waste Collection information

Cornwall Cllrs have been sent more information regarding the new waste collection service that will begin in the area from April 2024. There has been some controversy over this project as it has taken a good while to get the vehicles needed in place. You might have recently seen in the press about the cost to Cornwall Council of storing the replacement bins for the last few years - Councillors were assured in Full Council last week that if those bins had been brought now, the increase in the cost of them would be approx. the same as the cost of storing them has been.

From April 2024 (or just before) residents will start receiving new waste containers. These will be 180l 'wheelie' bins, if a property is not suitable for a wheelie bin - ie, it is a flat or doesn't have storage space - they will receive 180l seagull sacks. In addition, each property will receive indoor and outdoor food waste containers. The new cycle for collecting waste will be:

Wheelie bins (black bag waste) - fortnightly Outdoor food waste containers - weekly Recycling - fortnightly

Dark skies

In my last update I updated you all on the "dark skies project" - I have now been informed that it is not being labelled as Dark Skies, but is a cost saving exercise. Which is what will all assumed anyway. I asked a question of the portfolio holder about risk assessments being carried out in rural and coastal communities that have a night-time economy. I have been promised a written response and as soon as I have that I will pass it on to PCs.

<u>Highways</u>

Last week, I met with Cormac about the first of the Highways schemes for the area, which is the St Johns Rd crossing in Millbrook. This is now at design and will be out for consultation in the Autumn. The other schemes in our division, should be going for design in the Autumn.
