	Torpoint Project 1 – One Public Estate Bid & Removal of the Police Station	
	The consultant was pleased to advise that all the surveys on the Police Station are now complete. Information regarding the proposed cost of the demolition is anticipated in the next few days. Once this figure is known, additional funding may be needed, the deadline for this information is one week's time.	
	Torpoint Project 3 – Community Levelling Up Programme – Mobility Hubs	
	(TITAN)	
	The contract with Arcadis Consulting (UK) Ltd is continuing and the progress meetings and workshops have taken place according to the programme. The final submission of the report is scheduled for 11 th December 2023. The tour of sites was undertaken and the six sites [for this feasibility study] have been agreed: - two in Torpoint, one in Wilcove, one at Antony, one at Rame Head car park, one at Mt. Edgcumbe (actual location to be confirmed). The recent workshops considered what key features each hub require, in order of priority. Following the recent workshop, Councillor Kate Ewert had requested (via the consultant) information [from Aracadis Consulting Ltd.] about the cost to undertake a similar feasibility study for the six sites is being undertaken. The consultant explained this information has been emailed to Councillor Ewert, with a reminder this cost does not include any consultant/administrative expenditure. Councillor Ewert will forward this information to Maker with Rame Parish Council.	Cllr Ewert
	Torpoint Project 4 – BUS006 Bid for Feasibilities on New Build	
	The consultant advised the Invitation to Tender (ITT) has now closed and there had been a delay in holding this meeting, due to the high number of bids received.	
	The consultant drew members' attention to another funding opportunity which had been posited, via Cornwall Council, the opportunity to bid for Community Levelling up funding for a feasibility study towards 'Veteran's Housing'. Members' gave their full support to this suggestion.	
	Torpoint Project 5 – CLUP Bid Cycle Connectivity across Torpoint & The Rame Peninsula The consultant detailed there are bids available for sums up to £200k. With the Arcadis Consulting (UK) Ltd. report due on 11 th December 2023, there is an	

	 opportunity to use the report to make a further bid to deliver some/possibly all of the 6 mobility hubs. The consultant would need confirmation from the other Parish Councils whether they wish to be included in this funding bid. Members' were enthusiastic to bid for further funding and approved the suggestion for the two Torpoint sites. Councillor Kate Ewert will liaise with Mount Edgcumbe as well as write to the other Parish Councils, to establish whether they wish to be included (Maker with Rame PC and Antony PC), although the consultant advised that Antony Estate has given the go ahead as landowner (for the hub at Antony). The consultant has asked for a definitive answer as soon as possible. Other Items' The University of Plymouth BSc Lecture is completed. Also MSc students will be commencing projects shortly.
