

OPEN FORUM

Mr A Levett – Reading the correspondence, previously circulated to Members [see Agenda item 13 (d)] Mr Levett highlighted parking problems and the shortage of parking spaces, particularly in the daytime, at Arthur Terrace, Belle Vue Square, suggesting 'residents parking' or 'pay and display' for non-residents could be installed. Mr Levett also highlighted concerns about parking in the town centre. Councillor G J Davis, having discussed this with Mr Levett previously, summarised the options available which include applying individually to Cornwall Council for a privately allocated space. Another option could be to include a recommendation to apply to Cornwall Council to review the parking arrangements (at this location) with the possibility of including this within the Town Council's Expression of Interest, part of Cornwall Council's Community Networks Highways Scheme.

Mrs K Beats (accompanied by a neighbouring resident) - As a resident from Lamorna Park highlighted a recent incident (2 weeks ago). A business operating at Trevol Business Park, Specialist Blasting Services (SBS), created an "horrendous noise, undertaking sand blasting" on a weekend afternoon which continued into the evening. The noise levels were deafening. An angry resident spoke to an employee working at the site, who was invited to listen to the noise levels from Lamorna Park. A complaint was raised with Cornwall Council Environmental Services and this is being pursued. Members remembered a similar complaint about the excessive noise levels at this location and have raised concerns with Cornwall Council in the past. Councillor S J Corbidge detailed the actions he has undertaken as a resident from Lamorna Park.

82-18 Cornwall Council Report Councillor G J Davis explained it had been a quieter month, with no further update on any current issues. Councillor Davis highlighted attending meetings relating to the current Electoral Boundary Review explaining this will require discussion at this Town Council meeting (see Agenda item 7(a)). Councillor Davis is continuing to liaise with Cornwall Council's Environment team about the poor state of the hedge at Cambridge Field, although unfortunately an outcome on this is not expected immediately. Councillor Davis will pursue the local area steward about the wooden fence alongside the A374, near to Thanckes Park, currently lying on the ground. A request for a gateway/entrance at this site has been submitted alongside the requested repair.

 85-18 Matters arising from the minutes a) Local Government Boundary Commission for England (LGBCE) draft recommendations: - Pursuant to minute 58-18 (b) Councillor G J Davis updated members on Cornwall Council's discussions on the electoral review proposals. A brief presentation detailing the electorate numbers in each street in the current Torpoint West Division was explained by Councillor Davis and the various options available to try to equally align the number of electorate in the proposed 'Torpoint East' alongside the proposed Division, which is likely to incorporate St. Germans and the Rame Peninsula. After discussion and using graphical presentation with the streets identified as letters of the alphabet (for ease of explanation), it was resolved: the proposed boundary for the division of Torpoint be placed where the stream running under Trevol Road is currently located those houses/streets to the right-hand side of the stream remain in Torpoint East and this will include those streets identified by the letters U (electorate 381), Q (electorate 79), R (electorate 72) & Y (electorate 178) on the map shown those houses/streets to the left-hand side of the stream will be in the proposed new 'Torpoint and the Rame Peninsula' Division, whilst acknowledging the proposed solution will result in the Torpoint East Division being under represented when comparing electorate numbers with the proposed 'Torpoint and Rame Peninsula' Division. Members were mindful this solution could present issues for the current Torpoint West Division residents feeling segregated and not part of the local community. It was resolved to stress the importance to Cornwall Council that 'Torpoint' is included in the name of the proposed new Division (incorporating the Rame Peninsula and St. Germans). The recommendation of 45-18AMO (a) (Grace and Glamour) was withdrawn, the Clerk will seek clarification on the correct way forward, whilst ensuring Standing Orders are adhered to. Pursuant to minute 39-18AMO (c) Replacement Bus Shelter the Clerk advised the three-bay bus shelter located on Trevol Road, immediately next to the Spar shop, had been replaced today. Pursuant to minute 40-18AMO (Antony Road public conveniences) Councillor G J Davis highlighted his frustration about the committee decision to reduce the opening times, and in his opinion felt this was not the correct way forward. Members responded that the decision had been debated and hoped the restrictive opening times would discourage the public conveniences from being left in an unhygienic state. Re-iterating this is for a trial period, due for a review after four weeks, it was agreed that more publicity was needed when the opening hours changed in the future.
