Supply and installation of Tennis Court Fencing, Thanckes Park, Torpoint, Cornwall

BRIEF DESCRIPTION

The Town Council is seeking quotations from suitably qualified contractors to undertake the removal of existing tennis court fencing and the supply and installation of replacement fencing at the tennis courts, Thanckes Park, Torpoint, Cornwall, plus the disposal of all waste from site.

RETURN DATE/VALIDITY

For your tender to be considered it must be: -

- Returned to the Town Clerk & RFO by **midday on Tuesday 2nd February 2021** and should remain valid for acceptance for ninety days.
- Your tender should be submitted in the format as detailed in Annex C. Failure to provide a tender in compliance with the above may result in the tender being rejected.

QUALITY

The requirements as detailed within the Scope of Requirements at Annex A shall apply. You are required to state any Quality Assurance/Trade Body Certification you may hold, both now and expect to hold at Contract award.

PROGRAMME

The programme of works is detailed within the Scope of Works Annex A. However, the following is noted:

➤ It is anticipated this contract will be awarded by Torpoint Town Council at the Council meeting to be held on Thursday 18th February 2021 (assuming the tennis courts have been devolved from Cornwall Council – expected completion 11/01/21).
