My name is Mrs Priscilla Gulley and I live at 58 Woodland Way with my husband Trevor - he's a councillor for Torpoint. We have been at this address since 2009 and love the place very much but there seems to be a chronic problem of speeding caused by a small minority of drivers there.

Our older cat was run over in 2011 but was lucky enough to survive although he needed surgery with pins and plate attached to his leg and a long recovery time as well as a hefty vet bill. I was just glad he made a full recovery but the heartache was awful only for it to happen again on Easter Sunday morning, this time to our 11 month old beautiful Burmese girl, she was very much loved and cared for. She was run over and killed instantly outside our gate and again the person who did it just drove off. My poor husband found her dead by the curb, we are both terribly stricken by grief.

We are not the first to be going through this horrible heartache, other neighbours had this happening and I feel it's about time something is done. This sort of thing should not be happening at a cul-de-sac but It's only a matter of time it happens to young children - they ride on the road unsupervised and quite often come shooting from the side roads along Woodland Way onto the main road. It's a tragedy waiting to happen.

I have contacted Torpoint Council regarding the possibility of having speed bumps put along the road - Millie assured me it will be discussed when the new council discusses highway proposals for the future.

I have also contacted Cornwall Council who suggested me to get in touch with you. I don't know how you could help us or what could be done but I feel strongly this has got to stop before something more awful happens. People shouldn't be going through this heartache anyway.

I thank you in advance and look forward to hearing from you.
