114-21 Suspend Standing Orders The Chairman proposed that Standing Orders were suspended, this was seconded by Councillor Mrs. J M Martin and it is resolved that Standing Orders were suspended until 7.11pm.	
Apologies for absence: - Apologies for absence were submitted on behalf of the Town Mayor (Councillor Miss. R A Evans BEM) and Councillors Mrs. L Fellows and M G Spurling.	
Mayor's Chaplain Father Michael Brown submitted his apologies for absence.	
116-21 Declarations of Interest relating to items on the Agenda None declared.	
 117-21 Planning Applications: - a) PA12/09208 – Conversion of part of commercial basement to residential apartment (1no. new dwelling house) with associated internal and extern alterations. Extension of existing 2nd floor apartment over footprint to existing rear tenant. No observations and no objections. 	
Councillor J Tivnan BEM had previously circulated his written report for the Council's consideration. Councillor Mrs. J M Martin wished to bring to the attention of the Council, the current struggle our schools are having regarding Covid-19, which is still impacting teachers' and students', with positive cases resulting in isolation. Questions have been raised to Cornwall Council who have instructed schools to continue as 'normal' and have asked schools to record positive cases as 'ill absence'. School Governors are becoming increasingly concerned about the teacher's mental health needs and believe this should be escalated to Parliament through Sheryll Murray MP. Following a question posited by the Chairman (Councillor G J Davis), Councillor J Tivnan BEM clarified a meeting took place with the Tamar Bridge and Torpoint Ferry Joint Committee in September, with another report being published in December 2021. Councillor G J Davis highlighted issues with parking bays and an error in the road markings regarding resurfacing works carried out by Cormac in Fore Street. Councillor J	



Tivnan BEM explained he had been in contact with Highways and made them aware of
the issue as the parking bays are only 1.7meters to 1.8 meters wide, which poses a
further problem as cars of today are approximately two meters wide. Highways
responded stating parking bays should be a minimum of 1.8 meters wide and therefore
the markings have adhered to the rules.

119-21 Police Activity Report: -

The Police activity report is noted. A member questioned why the Stalking and Harassment crimes reported figures have significantly increased. The Clerk had questioned the Neighbourhood Police Officer, who had not given any indication of concern about these figures.

120-21 Minutes of the previous meeting: -

The minutes of the previous meeting held on Thursday 17th September 2021 (as circulated) were taken as read, confirmed and signed by the Deputy Mayor (Councillor G J Davis).

122-21 Mayor's Communications

The Deputy Mayor (Councillor G J Davis) spoke on behalf of the Mayor (Councillor Miss. R A Evans BEM) who had expressed her concerns to Wildanet regarding the safety of our residents, whilst they were carrying out work in Fore Street. They have since replied apologising, but they did not acknowledge the safety concerns expressed by The Mayor. The Deputy Mayor (Councillor G J Davis) thanked everyone for attending the Freedom Parade also the Civic Service and Parade and gave a special thank you to Council Officers and staff for all their assistance on the day.

The Mayor (Councillor Miss. R A Evans BEM), Deputy Mayor (Councillor G J Davis) and the Deputy Mayor's Deputy (Master G Davis) have visited Tartendown Nurseries to pick this year's Christmas tree.

The Deputy Mayor (Councillor G J Davis) was invited to attend the opening of the newly refurbished St. John Village Hall on 21^{st} October along with Mrs Kate Jackson, who attended St John Cookery School as our 'head baker'. Councillor G J Davis commented on how nice it is that the Council is being invited to attend events again.

The Christmas Tree Festival at St. James Church will be run again with council support.

123-21 Minutes of the Asset Management and Operations Committee

It was **resolved** the minutes of the meeting held on Thursday 23rd September 2021 (as circulated) are received and pursuant to minute number 48-21AMOC (Quinquennial Survey) it is **resolved** to delegate to the Asset Management and Operations Committee to consider the quotations and select the suitable contractor, and 49-21AMOC (Enforcement – flexible approach) is adopted and implemented.

124-21 Minutes of the Finance and Personnel Committee

It was **resolved** the minutes of the meeting held on Monday 4th October 2021 (as circulated) are received, there were no **recommendations** in the minutes.

125-21 Minutes of the Development and Localism Committee

It was **resolved** the minutes of the meeting held on Thursday 7th October 2021 (as circulated) are received and 68-21D&L (a) (Community Hub and Library – Abolishment of fines) and 74-21D&L (a) (Devolved sites/tennis courts) to work in partnership with the LTA to install the Lite gate, instead of the Premium gate as formerly detailed, are adopted and implemented.



Pursuant to minute 73-21D&L (a) (Development Plan Strategy), the Clerk explained the updates to the Council's Strategy are not yet completed and it is agreed to defer this to the next meeting.

126-21 Questions of which notice has been given or notice of motion.

"The time is right for Torpoint Town Council to declare a Climate Emergency. Climate Change is already being felt across out County. 'Ambitions action is undoubtedly needed from Governments and Industry but bottom-up change is crucial too, and if enough of us act it really can have a huge combined impact.' Cornwall Climate Care. Our aspirations for the regeneration of the lower end of town, the electric ferry water taxi work on cycle and walk routes and improvement in transport connectivity all have their routes in sustainability and reducing the carbon footprint in our town and the peninsula and demonstrate that there is a Climate Emergency and that steps need to be taken to deduce our carbon footprint. Declaring a Climate Emergency will be pivotal in widely encouraging and increasing community engagement with environmental and sustainability issues. I believe, as a Council, we have a duty to take the lead and declare a Climate Emergency now."

"Proposer: Councillor Mrs. C E Goodman – signed 14th October 2021. **Seconder:** Councillor C R Sawyer – signed 15th October 2021.

Following the proposition being put, this was seconded by Councillor Sawyer who detailed his reasoning, an in-depth discussion took place. All Members were given an opportunity by the Chairman to ask questions and give their opinions and it **resolved** for Torpoint Town Council to Declare a Climate Emergency.

Following the Council's decision, the Chairman asked what next steps are planned and it is **resolved** to set up a Climate Emergency working party group. Members volunteering for the group are: Councillors Mrs. K Partridge, Mrs. C E Goodman, M Thomson-Neall and R M Willoughby, with the Town Mayor (Councillor Miss R. A. Evans BEM) invited to attend. This will now be a standing Agenda item on all future Council meetings, with a brief report provided by the working party for each Council meeting.
