Hi Catherine

Please could you communicate the plans below to relevant stakeholders in the Torpoint area.

These works are essential to mitigate for Ash Die Back in the area and mostly relate to safety. We will have the relevant felling licences and approvals in place, however, the works may raise some concerns within the community. Appropriate signage will be deployed before and during and works.

Goad Avenue woods (POS on the east side of St Antony's road):

This will involve felling a number of large diseased ash within the woodland strip between the sports field and the houses as well as some Ash removal and re-stocking in the small block to the east. The works will be carried out this winter- A works instruction has been issued but we do not yet have a start date.

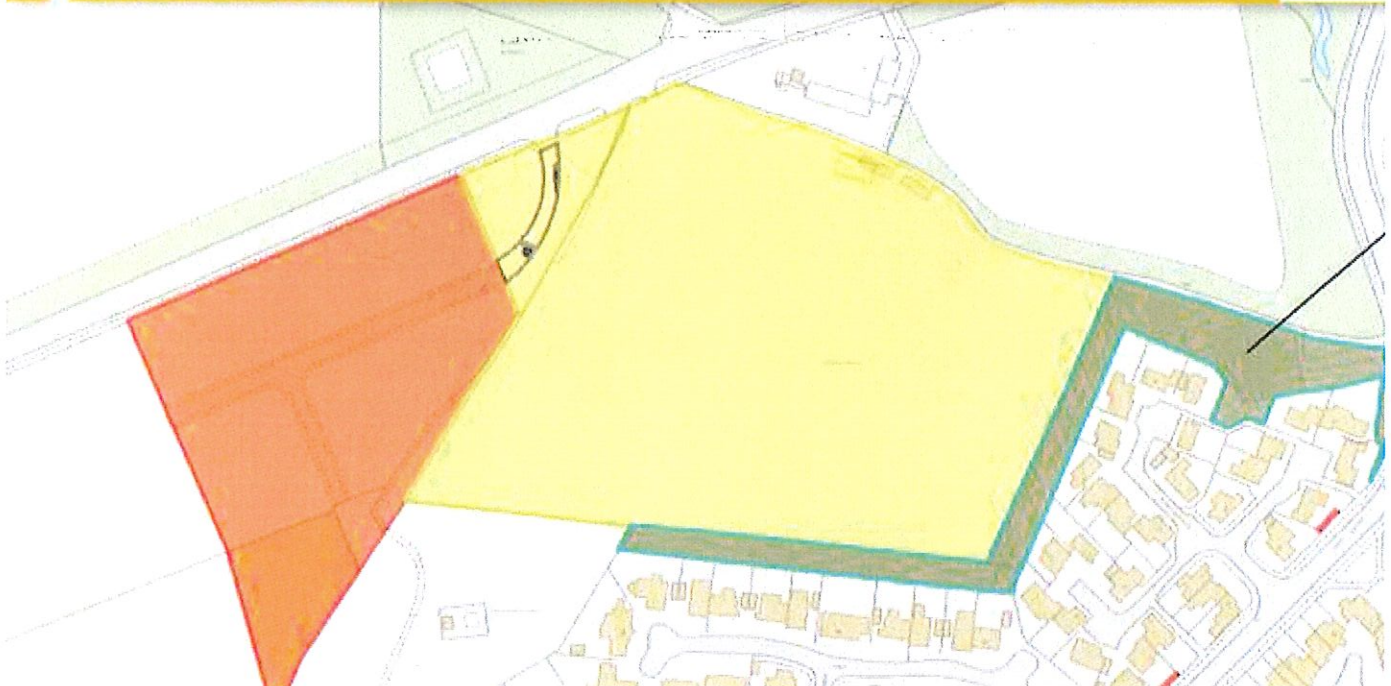
Quarry Park Bottom:

Felling of large boundary Ash trees.
Thinning of most of the Ash through the whole site and re-stocking.
Potentially to be carried out this winter

Borough Hill woods:

Felling of large boundary Ash trees.
Potentially to be carried out this winter

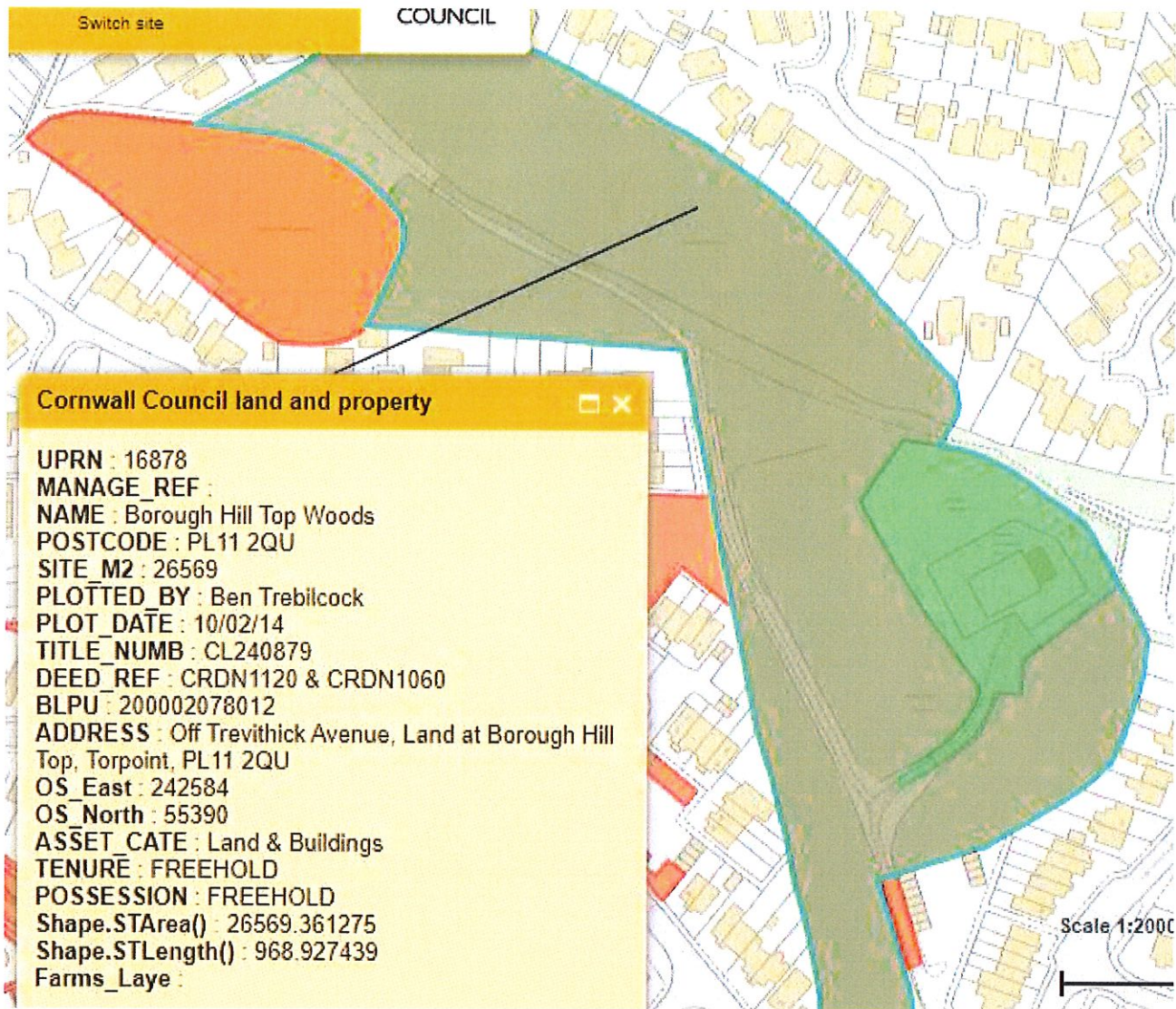
