since looking at pa21/01351 I have observed that on page v of the phase 1 ground investigation (assessment of land contamination it says care should be taken to assess and check for asbestos. This has clearly been ignored as the contractor moved thousands of tons of soil etc to a heap at the top end of the site. Also footings have been dug to a depth of up to 1.3M and arisings placed on to the heap at the top of the site. At no time has anyone appear to have been checking for contamination with 2 large hymac type machines moving material around the site at will.

The proposed start date was March but the started much earlier, was there time to check and assess the contamination of the site etc prior to start?

As the environmental officer observed a corner of asbestos sheet lying on the ground of the site why did he not think it sensible to have a closer look at the site.

surely it is the responsibility of CORNWALL COUNCIL to ensure that the possible contamination of surrounding areas are considered when building excavations etc is carried out.

If it wasnt for the wet weather the airbourne pariticles may have spread over large areas of TORPOINT.

It should not be up to a concerned individual to monitor and ensure that sites like this are correctly monitored.

I have checked the planning history at Trevol Business Park and note that planning permission was granted under reference PA21/01351 for the development of 10 B2/B8 Industrial units with associated road and parking. Within this permission conditions 5,6 and 7 relate to contaminated land.

From the information provided below it is not clear if this is the site to which you refer? If it is, then I can advise that there is currently an application to discharge conditions 3 (drainage), 5 (assessment of risk re. contamination) and 6 (Remediation scheme) of PA21/01351 and I would recommend you view the application documents submitted with this application via the following link Online planning register - Cornwall Council

Should you wish to submit any comments regarding this application, you can do this online where they will be registered and considered by the Case Officer.

If however this is not the correct application or site, please could you provide details of the exact site location and I can look into this again for you.
