i-Connect is coming!

Over the next few months, we'll be introducing i-Connect. This is a secure platform which automates the submission of pension data.

Once your organisation is "onboarded" to i-Connect, you'll move away from preparing year end returns for scheme members' data submissions to online monthly data returns.

The benefits to employers, your members and the Fund include:

- Reducing time spent on pensions administration
- Accurate data submissions
- No more year-end returns
- Fewer data error investigations
- Reducing the need for submission of data via individual forms
- Speedier response to your employer enquiries
- A user-friendly platform
- Secure data transmission

Over the next few months, we'll contact you about starting the process towards using i-Connect.

REMINDER | Employer training

We have arranged for our actuary Hymans Robertson, to run some further free virtual employer training sessions:

- Friday 10th June 2022 (11am to 12:30pm) covering pension outsourcing
