#### BENODET PARK TENNIS COURTS AND PARK

# **CAMERA ONE**

A 2mp white analogue bullet style camera with a 2.8mm fixed lens and infra-red capabilities for night time viewing is to be installed on a pole for the general view of the playpark

#### **CAMERA TWO**

A 2mp white analogue bullet style camera with a 2.8mm fixed lens and infra-red capabilities for night time viewing is to be installed on a pole for the general view of the gate to the tennis courts

# **CAMERA THREE**

A 2mp white analogue bullet style camera with a 2.8mm fixed lens and infra-red capabilities for night time viewing is to be installed on a pole for the general view of the new disables access to the tennis courts

## RECORDING EQUIPMENT

The existing recorder in Benodet Park is to be utilised but the hard drive will be replaced with a 6TB one to account for the additional camera

### **CAMERA MOUNTING**

A 4.5m modular fixed square section pole with lockable access is to be installed in the right hand corner of Benodet Park (this is to be supplied by Security Dynamics)

# **NOTES**

A concrete base is to be supplied and installed by others at NO cost to Security Dynamics

Ducting is to be supplied and installed from the tea hut to the camera pole base by others at NO cost to Security Dynamics. Alternatively at an additional cost, Security Dynamics can place conduit along the wall.
