# Who are we campaigning for?



We're campaigning for **those being hit hardest by the toll rises** during this unprecedented cost of living crisis:

- People accessing medical or dental care at Derriford Hospital or elsewhere in Plymouth
- Families supporting relatives on opposite sides of the River
- Carers making frequent trips across the Tamar to look after their clients
- Parents taking their children to school
- SE Cornwall business owners

# Why are we campaigning?

We're campaigning to reduce the **cumulative significant impact** on local residents and businesses.



- Plymouth and Cornwall have deprived areas and the area as a whole has lower than average wages
- High costs for people crossing multiple times a week for work
- Toll collection impact on congestion and pollution
- Inherent accident risks from multiple toll booth lanes converging
- Charges for deliveries to Cornwall that are free to deliver to Plymouth
- Current Government strategy on levelling up and Devolution deal

## **Background to the Campaign**



### Our aim is to create the political will for our actic Councillors and MPs to fight for change on our behalf and obtain central funding for the crossings

# Background to the Campaign



- Groundswell for change has been intensified by recent events, i.e. the unfair tag price increase 9 months prior to cash price increase
- Tag price increased by the Tamar Crossings prior to consideration of the public consultation results
- We are seeking a fair deal for residents, businesses and other regular users of the Tamar Bridge and Torpoint Ferry

### **Comparison with other bridge tolls**



Bridge Location	Car Cost	Concessions	
Tamar Bridge	£2.60	50% off for tag	
Dartford Crossing M25	£2.50 (each way)	£20 per year for locals	
Mersey Gateway Bridge	£2.00 (each way)	£10 per year for locals	
Mersey Tunnels	£1.80 (each way)	80p for locals	
Tyne Tunnels	£1.90 (each way)	10% discount for pre-pay	
Humber Bridge	£1.50 (each way)	10% discount for tag	
Whitney Bridge	£1.00	60p multi-crossing per day	
Clifton suspension bridge	£1.00 (each way)	57p for multi-buy	

Bridges marked as charging each way are significantly longer than the Tamar Bridge. i.e. Tamar – 642m Dartford – 2872m Mersey Gateway – 2200m Humber – 2220m

The Joint Committee plan to ask the Government to consider allowing tolls to increase annually and automatically in line with inflation and the Retail Price Index (RPI).



# Why both crossings?

 The Torpoint Ferry and Tamar Bridge are important routes between Devon and Cornwall, both providing critical transport links to their respective local communities for many essential services



- There is **no viable alternative route for either community** the alternative is via single lane 500 year old bridge at Gunnislake weakening the bridge and contributing to pollution in Gunnislake.
- The bridge and ferry are **conjoined by the Tamar Bridge Act**; the responsible authorities are common. It is counterproductive to try and treat them as separate issues and campaign only on behalf of one, and would divide the communities.
- We reach out to residents of the Torpoint and Rame Peninsula for their support and combined voice in lobbying our shared MP.
