Ill health retirement

As an employer, one of your responsibilities is to make a decision regarding eligibility for ill health retirement benefits in respect of your current and previous Local Government Pension Scheme (LGPS) members. Failure to complete this process without undue delays can have a significant financial impact on the scheme member and, if they are gravely ill, upon their family if the process is not completed in a timely manner. This would also leave you as their employer or ex-employer open to complaints under the pension scheme's Internal Disputes Resolution Procedure (IDRP) and ultimately the Pensions Ombudsman.

If you outsource your Occupational Health services, please make sure you are aware of any costs involved and confirm with your provider they have a suitably qualified Independent Registered Medical Practitioner (IRMP) available to complete the assessment.

Inducement to opt out

Within the pension regulations safeguards are put in place for members, including the prohibition of employers encouraging them to opt out or leave a workplace pension scheme, such as the Local Government Pension Scheme (LGPS).

It is also worth noting, that you are not permitted to issue an opt out form to any staff, as this can be seen as inducement to leave the scheme – these forms can only be obtained by the member directly from us or by them completing the form online via our website.
