**INTRODUCTION:**

Internal auditing is an independent, objective assurance activity designed to improve an organisation's operations. It helps an organisation accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control, and governance processes.

**Scope:**

The scope of the audit covers, as a minimum, the areas included in the Internal Audit Report contained in the Annual Governance & Accountability Return and the Transparency Code.

**Approach:**

Audit work is carried out in line with the Chartered Institute of Public Finance and Accountancy's Internal Audit Standards and guidance issued by the National Association of Local Councils.

Where applicable we have included reference to 'proper practice' and the associated guidance as laid out in 'Governance & Accountability for Smaller Authorities in England' which is applicable to financial years from 1st April 2022.

Selective testing was carried out and the relevant policies, procedures and controls were reviewed.

**GENERAL COMMENTS:**

We would like to thank the Clerk for their assistance and co-operation during the audit.

The matters raised in this report are only those which came to our attention during our internal audit work and are not necessarily a comprehensive statement of all the weaknesses that exist, or of all the improvements that may be required.

It should be noted that assurance can never be absolute. The most that the internal audit service can provide is a reasonable assurance that there are no major weaknesses in risk management, governance, and control processes. The audit does not guarantee that the accounting records are free from fraud or error.

***The review undertaken obtained a level of assurance which has allowed us to complete the Internal Audit Report element of the Annual Governance & Accountability Return with no qualifications, thus in all significant respects, the control objectives were being achieved throughout the financial year to a standard adequate to meet the needs of the Council.***

Attached is a copy of the completed Internal Audit Report required as part of the Annual Governance & Accountability Return.

## AUDIT COMMENTARY:

Items in **bold text** within the body of the report represent our findings in respect of the application of controls, text in *italics* represent suggested actions that fall short of being a formal recommendation or do not necessarily pertain to the application of internal controls.

### **A Appropriate accounting records have been properly kept throughout the financial year.**

**The accounts are maintained on Xero accounting software; they were up to date, in balance and free from material errors.**

### **B This authority complied with its financial regulations, payments were supported by invoices, all expenditure was approved, and VAT was appropriately accounted for.**

#### *Financial Regulations*

**Financial Regulations were last reviewed in October 2022.**

#### *Purchasing*

**Purchase orders are in use and quotes are obtained where required.**

#### *Payment*

**Payments are supported by invoices, are certified by the RFO and are included on payment schedules approved by Members.**

#### *VAT*

**VAT had been accurately recorded.**

### **C This authority assessed the significant risks to achieving its objectives and reviewed the adequacy of arrangements to manage these.**

#### *Insurance*

**Statutory insurances are in place and the Fidelity Guarantee is adequate at £750K.**

#### *Risk Assessment & Internal Controls*

**The Council has reviewed its risk assessment and the effectiveness of its internal controls; there is still no 'scoring' of risks within the assessment to quantify their relative likelihood or severity.**

#### *Cash*

**The Investment Strategy was reviewed in May 2022.**

### **D The precept or rates requirement resulted from an adequate budgetary process; progress against the budget was regularly monitored; and reserves were appropriate.**

#### *Budget setting*

**The 2023/24 budget and precept were approved by Council following the production of detailed estimates.**

**The approval took the form of agreeing the recommendations from the Finance & Operations Committee.**

*Full Council is required to approve the budget and precept so for the avoidance of doubt it would be sensible to replicate the actual recommendations in the Council Minutes ensuring the amount of the precept is included.*

#### *Budget monitoring*

**Budget monitoring activity is provided to each meeting.**

#### *Adequacy of Reserves*

**After allowing for earmarked reserves of £138,887 the general reserve stands at £205,590;**

equating to 34% of gross expenditure which is within generally accepted parameters.

- E Expected income was fully received, based on correct prices, properly recorded, and promptly banked; and VAT was appropriately accounted for.**

*Precept*

The precept received was checked to the records of the Council and the principal authority and found to be in accord.

*VAT claims*

VAT claims for the year have been submitted. There was a small discrepancy between the final claim and the balance in the accounts which should be rectified when the next claim is submitted.

*Room Hire*

Room hire is managed through a booking system, hirers are invoiced and fees were correctly applied.

*Library & Cafe*

Income is controlled via a till with card payments posted to the ledger daily and cash banked and posted weekly.

*License income*

Licenses have been charged in accordance with the 5% upgrade agreed as part of the budget setting process, other than those licenses excluded by resolution of Council.

*Interest*

Interest on the Councils investments has been accurately reflected in the ledger.

- F Petty cash payments were properly supported by receipts, all petty cash expenditure was approved, and VAT appropriately accounted for.**

- G Salaries to employees and allowances to members were paid in accordance with this authority's approvals, and PAYE and NI requirements were properly applied.**

Testing of the payroll for the last quarter of the year revealed no issues to report.

- H Asset and investments registers were complete and accurate and properly maintained.**

The asset register has been updated to reflect acquisitions and disposals and the total value of assets held is accurately reflected in the AGAR.

- I Periodic and year-end bank account reconciliations were properly carried out during the year.**

Monthly bank reconciliations have been carried out in a timely manner and have been reviewed by a Member in line with Financial Regulations.

The year-end bank reconciliation was found to be accurate.

- J Accounting statements prepared during the year were prepared on the correct accounting basis (receipts and payments or income and expenditure) agreed to the cash book, supported by an appropriate audit trail from underlying records, and where appropriate debtors and creditors were properly recorded.**

The accounts were produced on an income and expenditure basis and were in accord with underlying records.

An audit trail was provided and accompanying information required by the external auditor produced.

- K IF the authority certified itself as exempt from a limited assurance review in 2021/22, it met**

**the exemption criteria and correctly declared itself exempt.

**L The authority published the required information on a free to access website/webpage up to date at the time of the internal audit in accordance with the relevant legislation.**

Proper guidance on this will not be available until after the deadline for AGAR submission and my discussion with the external auditor suggests it is left to internal auditors to interpret. My view is that is intended to only apply to Exempt authorities who have additional publication requirements, which excludes this Council

However, as the Council has met the requirements of section N below and its website is up to date and provides information that would reasonably be expected to be there, I have ticked the 'yes' box rather than 'not covered' to ensure that time and potentially money is not wasted replying to the external auditor should they query a 'not covered' response.

**M In the year covered by this AGAR, the authority provided for a period for the exercise of public rights as required by the Accounts & Audit Regulations**

The AGAR was properly approved by Council, the requisite Notice was published and the correct number of days for public inspection were allowed

**N The authority has complied with the publication requirements for 2021/22 AGAR.**

All publication requirements were met.
