Hello all

Amy Looker, the Highway Technology & Asset Systems Manager, has sent the message below to CLO's and I wanted to seek your feedback as to whether there may be any areas that could be positive to the concept of a switch off between midnight and 5am.

I am aware that some approaches were made previously in the former Cornwall Gateway CNA but do let me know if there are any parishes you would like me to put forward. And/or if you would like to meet Amy to discuss this further:

We're progressing with our risk assessing of streetlights to see which can be switched off in the near future (between midnight and 5am) – no firm date yet but hope to begin at some point before August.

Although the switch-off is not optional, we would like to start in areas where there is likely to be a positive reception to the changes so wondering if any of you know any parishes with Highway Streetlighting that would be happy to be in the first round of part-night switch-off. The ones we've thought of so far based on our previous interaction are as follows;

- St Just
- Mylor
- Areas of Bodmin Moor

If you are aware of any others, or know the above may have changed their views, please let me know.
