Good Afternoon,

Thank you for responding to the consultation regarding the renewal of the Public Spaces Protection Order for Dogs on Leads, Dogs on Leads by Direction, Dog fouling and Dog Exclusions. We can now confirm the process is complete and it has been agreed that the orders will be renewed for 3 years.

We were not able to accommodate all the requests for additional areas to be added to the Dog Exclusion Order and the Dogs on Leads Order but this doesn't prevent Town and Parish Council's or land owners implementing their own restrictions, simply there will be no enforcement by means of the PSPO available. All enclosed play areas and the requested skate park have been added to the order for Dog Exclusions. For the new areas Cornwall Council will provide a maximum of two signs at the entrances and no enforcement can take place until these are in place and a clearly fenced boundary must be in place. I am currently getting these signs printed, if Town or Parish Council's want additional signs please let me know and these will be available for purchase. I will contact Council's individually when they are ready.
