Torpoint Mosquito Sailing Club is an organisation with it roots firmly set in the heart of the town. The club was founded in 1891 and has a long history of sailing from historic Mosquito class boats through to modern dinghies and yachts. More recently the club has developed into a modern family friendly and fully inclusive water sports centre offering traditional sailing facilities, including year-round dinghy sailing; twice a week in the summer and weekly over the winter months! Additionally, the local sub agua club also meet and operate from the club. Our cadet training organisation consistently operates at capacity offering sailing sessions for young sailors and is a great example of our community focused spirit. Whilst we consider ourselves to be a local club, many of our sailors venture further afield to represent the club, and consequently the town, at national and international sailing events. Post COVID pandemic the club has seen an upturn in participation by members of the local community that has placed a burden on our facilities and finite resources. Despite the current cost of living situation, the volunteers of the management committee continually strive to provide club activities at the most cost effective means possible. At the centre of the water based activities is the requirement to provide safety cover whilst afloat utilising our club safety boats and it is these that have born the burden of the increase in activities afloat.
