#### **Project Overview**

Torpoint Artists Collective (TAC) was founded in 2024 by local artists to create a supportive network for creatives living and working in Torpoint and nearby areas. As a newly formed social enterprise, TAC aims to enrich the cultural landscape of the town by developing accessible creative spaces, nurturing community engagement, and unlocking Torpoint's cultural potential.

#### The 61 Fore Street Project

TAC has secured a lease for the currently vacant property at 61 Fore Street, which we plan to transform into a vibrant community arts hub. The vision for this space includes a gallery and education area in the shopfront, TAC's office, and artists' studio space in the room behind. This center will be more than just a gallery - it will be a fun creative hub where local (and visiting) artists can exhibit their work, lead workshops, and connect with the community.

To bring this vision to life, TAC will attract grant funding over the next 24 months to invest in renovating and enhancing both the interior and exterior of 61 Fore Street. #### **Immediate Need for Council Support**

These insurances are necessary for us to begin work in the space and initiate our project. With the council's support, TAC will be able to commence our lease and start the transformation immediately, allowing us to open this new creative hub to the community as soon as possible.

By supporting TAC's start-up phase, Torpoint Town Council will play a crucial role in establishing a sustainable, community-focused arts hub that will provide ongoing benefits to the town. Once operational, TAC will:
