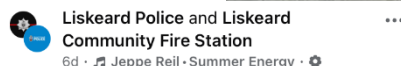

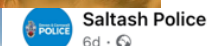
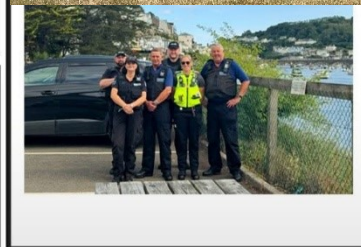

Alongside the team at Liskeard Community Fire Station, we recently ran an interactive session to help keep young people, including those who are new drivers, safe on the road.

On the day, we spoke to college students about what would happen if they were involved in a collision and what emergency services would do to help them. We also spoke about the five most common causes for collisions to encourage the students to make safe decisions now and in the future, whilst highlighting the consequences of dangerous choices.

This forms part of our approach to keep young people and drivers safe on the road.



The unauthorised encampment on Warfulton Field have now left. This field is owned by Cornwall Council who are responsible for any enforcement at this location. Cornwall Council served their direction to leave however this was not adhered to by the deadline of 16:00 on Sunday 27th July. They therefore started eviction proceedings, which would need to await for an available court date. On Monday 28th July the Saltash Neighbourhood Team gathered evidence in relation to significant disruption and significant distress caused by the unauthorised encampment, and with the confirmation that Cornwall Council had given their direction confirming that the encampment was there without consent, have utilised powers under the Criminal Justice and Public Order Act 1994 to issue a Notice to Leave. Failure to leave by the deadline could result in arrest and vehicle seizure. This notice was successful, and the unauthorised encampment left overnight. We would like to thank the public for your support with this. Please continue to report any concerns to the Police.

The Liskeard Police Neighbourhood team, working with Devon & Cornwall Police Legal Services Team, Cornwall Council's Anti-social Behaviour Team and LiveWest Housing Association, were recently successful in their application to Cornwall Magistrates Court, for a premises closure order for a property on Pengover Park, Liskeard. The premises, which was associated with significant and persistent disorder, is now closed for a period of three months. The decision to apply for closure order is not one we make lightly. It is a process that involves a lengthy investigation and lots of work with the community and our partners, during which warnings are given and opportunities to steer a different path are made available. Anti-social behaviour is harmful and we will continue to work with our partners and the community to put a stop to it and when it becomes necessary, we will not hesitate to take enforcement to do so.

Did you know that one of the roadside tests we can do in Devon & Cornwall is an eyesight test?

You need to be able to read a vehicle registration plate from 20 to 20.5 metres away.

If you can't, you could have your driving licence revoked.

It is a road traffic offence to be unable to read a number plate in good daylight.

Please make sure you have regular eye tests and that any glasses or contact lenses have an up-to-date prescription to ensure your eyes are up to the task!

Officers stopped this vehicle on Saturday evening after it was being driven with no insurance. The vehicle had been seen in the Saltash area during the week and been reported to have no insurance and when stopped, this was the case. This vehicle was seized and will cost the owner a storage fee to collect it, once it has insurance and the driver faces a £200 fine and 6 points on their licence.

Having no insurance causes financial and emotional distress to other road users when being hit by uninsured vehicles. We will continue to take vehicles like this off the road to protect our community. Please check your insurance policies to ensure you're covered, even when borrowing or using other people's vehicles with permission.



Police have been made aware of a rise in door-to-door sales in Torpoint and surrounding areas.

Although most door-to-door callers are simply trying to sell something, we appreciate some residents may feel intimidated by this- particularly if the visits are frequent or the residents are classified as vulnerable or are living alone. The Trading Standards Institute recommends putting up a 'no cold callers' sign to deter potential callers. If the caller ignores the sign and refuses to leave, you can report to police via 101 if you are not in immediate danger or 999 in an emergency.
