Public Spaces Protection Order, Review of existing dog bans on beaches

You may be aware that the current Public Spaces Protection Order creating seasonal restrictions for dogs on beaches in Cornwall will expire in April 2026, having come into force in April 2023. All PSPO's are valid for a period of 3 years at which point they must be reviewed and where appropriate consulted upon.

Please be aware that any additional restrictions above the current Public Spaces Protection Order will need to be supported with evidence to demonstrate that the threshold of nuisance is being exceeded. **Please return any comments by 15 September 2025 to publicprotection@cornwall.gov.uk**

We will also be undertaking a full public consultation with residents, businesses and visitors, and we will provide further information ahead of this commencing September 2025. Council officers will review your response and other feedback received through the public consultation and officers will present a report to the Council's Community Wellbeing Overview and Scrutiny Committee in January 2026 with a recommendation. The committee will then make a recommendation to the Portfolio Holder for Community Safety & Public Health, who will decide on the new Public Spaces Protection Order.
