Dear Ms Southworth,

I thank you for your response, its content is noted and I Will share it with my affected neighbours/residents.

I do have to say, that I Do Not and Cannot Not Believe that the Town Council is not responsible for Residents Health & Safety, I therefore request, on behalf of my neighbours, that this issue is raised at the Next Full Torpoint Town Council Meeting, as well as these issues being raised immediately, with the Cornwall Council Traffic and Road Safety Teams, based at and within Cornwall Council.

I further note (Ms Southworth), that the issue of the Extremely Faded Double Yellow Lines 'Has Not Even Been Addressed in Your Email' I therefore, respectfully request that the Town Council Formally Address this Long Outstanding Issue, as a Matter of Some Urgency, I and My Neighbours waited for Over Two (2) Years for the TRO to Finally be Approved, it took both Town and County Councillor Brian Hobbs and Cllr Davis to finally and belatedly Put it Through, I further Put On the Record, Ms Southworth:

That had the Double Yellow Lines themselves, been Appropriately and Professionally Painted in 2017, those Double Yellow Lines Would and Should 'Still' Be Fit for Purpose 'But They Were Not' I also believe that:

Had My Given Request, made in Mid-2024 to Torpoint Town Council (Phil), following that recorded failure I then raised it with Councillor Tivnan BEM in early January 2025:

I (Jack Connah), observe, that Had these Issues Been Dealt With Appropriately, that the Ongoing Issues would not be still outstanding, but it clearly wasn't and hasn't to this day, even been appropriately addressed.

I Ask of You (Ms Southworth), and the Lady Mayoress:

"Why does Torpoint Town Council Exist"?

If not to ensure the ongoing Health & Safety of the Town's Residents (The Prime Responsibility of Any Public/Local Authority), those Residents who ultimately Pay the Bills, including the wages and salaries of those Employed by Torpoint Town Council and Cover the Expenses of the Elected Local and County Councillors, who are responsible for their Personal Oversight of the Town, compliant to the Town and County (Cornwall) Council's clearly defined duties and obligations, who are clearly responsibilities in law as Elected Members of Town and County Council Public Authorities.

I believe it is reasonable of me (Jack Connah) to require-request, that both you (Ms Southworth), the Lady Mayoress (Councillor Martin), also both the Town and County Councillors Address these long running and (Evidently), ongoing unaddressed Issues, to ensure that they are lawfully and appropriately addressed by those Elected to Represent the Residents of Torpoint.

I do not feel Ms Southworth, under these circumstances, that an Email sent out Ten (10) Days after all three Councillors received a Formal Written Hard Copy Request for Their Involvement (13/8/2025), particularly in light of and following the already accepted failure of Councillor Tivnan BEM:

In that regard, I respectfully refer you (Ms Southworth), and the Lady Mayoress to and ask you both, to once again look at Cllr Tivnan's Email dated 10/6/2025 'Which in it's own right' Spoke Volumes, having done so, I respectfully

ask that you comply with your clearly defined duties, obligations and responsibilities, the very reason you and they, put yourselves forward for Public Office.

Further to receipt of correspondence regarding the ongoing parking issues being experienced on Bickern Road, whilst I am sympathetic I am aware there are a number of similar issues occurring around the town. Unfortunately, Torpoint Town Council does not have any traffic and parking enforcement authority and is therefore unable to actively address these issues. I have met with [Cornwall] Councillor Rob Parsonage and Councillor John Tivnan BEM and shared your correspondence; Councillor Parsonage will be in touch in due course to offer any further assistance.

For your information, Torpoint Town Council is considering any opportunities there may be to source additional parking enforcement for the town and funding of the same.

I am aware this is not the solution you were expecting, unfortunately it is beyond the remit of Torpoint Town Council.

Regarding the ongoing failure of Councillor John Tivnan BEM to Address the Issues:

'Reported To Him':

In Early January 2025 by a resident, on behalf of other Residents of the East Ward of the Council.

Madam Mayoress,

It is with great sadness, that I have no other option, but to escalate this, unaddressed complaint above the head of Councillor John Tivnan BEM.

I believe, as do other neighbours in Bickern Road, that Seven (7) Full Months, is more than long enough for an Elected Torpoint Councillor, to both address and resolve Two (2), very straight forward issues, despite his many other duties, particularly when the issues concerned are regarding the Health and Safety of His At Risk and Vulnerable Elderly & Disabled Ward Residents.

I (Jack Connah), initially raised the first of these issues (Worn-Out Double Yellow Lines at the End of Bickern Road, leading onto Moor View, immediately behind the Ex-Comrades Club), **Verbally with Torpoint Town Council with a gentleman (I believe called Phil), who the Lady answering the Phone at the Town Council Office, put me through to, in Mid-2024**, sadly, despite Him/Phil, assuring me that this would be reported to Cornwall Council & Therefore to the appropriate Officer concerned, the Worn-Out Double Yellow Lines (Initially Painted Badly in 2017), but only after and when, the Long Awaited 'Requested TRO' Finally Materialised after Two (2) Years of Formal Requests, that had been made, to initially Cllr Hobbs & Then to Cllr Davis (Upon Councillor Hobbs Retirement from Office), the Badly Painted & Clearly Rushed Paint Job, the Double Yellow Lines, remained in a very poor and deteriorating state and as you would expect 'One (1) Year On' Lady Mayoress, in July/August 2025, the lines themselves, are being and have been totally ignored by numerous Car Drivers, that are 'Parking On & Over the Double Yellow Lines' & Are therefore, blocking vehicular access into Bickern Road, as Other Vehicles, in a manner contrary to the Highway Code are Parking Directly opposite the (Adopted) Bickern Road, Road Access.

I (Jack Connah), now raise the Second (2nd), issue, an issue that, as a law abiding citizen, I myself, attempted to personally resolve from Early to Mid-November 2024, with the New Owners/Residents of 1, Bickern Road, who moved into Bickern Road Early November 2024 & Are a Two (2) Car Family.

They immediately, upon moving-in, started parking Two (2) Vehicles, in the Defined Turning Area at the Closed End of Bickern Road (Which Is a Council Adopted Road), I diplomatically contacted them in-writing, I brought this issue to their attention, but they failed to act appropriately and they continued to Block (And They Do So, to This Day), the Defined Adopted Turning Area, for up to 24 Hours each Day Seven (7), Days a Week, they responded, in-writing (27/11/2024 Copy Enclosed for Information), stating incorrectly, that they believed the turning area to be their own land and property, as stated in their Deeds, within a Plan Given to Them (Purportedly), by the Land Registry, they have failed, in all respects, to give disclosure of this obviously incorrect document/map.

I (Jack Connah), discussed this turn of events, with my neighbours, it was agreed that I would draw down, the Highways Maps from the Cornwall Council Highways Website (Copies Attached along with the Audit Trail of Written Documentation/Interactions with Cllr Tivnan), which 'I Did' & I Then as agreed 'Served Copies' Upon the Residents of 1, Bickern Road, as I had agreed with my neighbours, they (The Two Residents of 1, Bickern Road), did not respond, so I contacted Councillor Tivnan BEM, but, before doing so, I waited, until after Christmas & New Year Break, I then contacted him (Cllr Tivnan), by mobile phone, I did so, in very early January 2025, Councillor Tivnan, reacted and did so, immediately, he (Cllr Tivnan), came to see me at my home (As I am Profoundly & Severely Disabled), having listened to my Voice Message, left on his answer machine, he came into the property to see me, his (Cllr Tivnan's), first words were:

"People are Blocking the Turning Area, it's very inconvenient, I have had to park in-front of your gate and I'm blocking your neighbour's garage, so I can't be long"

It was the First and Only meeting, that I have ever had with Councillor Tivnan, **please note (Madam Mayoress), I hadn't told Councillor Tivnan, in my phone message left on his answer machine, why I wanted to see him,** I had just stated that I'm Severely Disable & Homebound and could he possibly come to see me, as I couldn't come to either the Council Offices, or His Home?

We (He & I), had a good laugh, about his first given statements, I then requested that he sort out the Badly-Faded Double Yellow Lines & Get Them Re-Painted, as I could not Exit or Access Bickern Road, with Any Vehicles Parked on the Corner/Start of Bickern Road, because of the vehicles parked daily (Also parked illegally), opposite Bickern Road, on Moor View, with My Large Wheelchair Accessible Motability Vehicle (Mercedes Sprinter WAV Van), he said, he fully understood on both counts and would address my concerns, as a matter of some urgency, but despite his (Councillor Tivnan's), given and stated intent, sadly, **nothing happened, on either count.**

I waited until Late February 2025, before I chased Councillor Tivnan, by mobile phone, he said he'd been extremely busy, but would deal with it, I waited until the end of March 2025, still to no avail, I chased Cllr Tivnan Again, this time, he (Cllr Tivnan), said:

"Oh, hasn't the Cornwall Council Officer been in-touch with You, I contacted the Officer at the Highways Department some weeks ago"

I told Councillor Tivnan, that 'I Had Heard Nothing, from Anyone, about the Re-Painting of the Lines' & I Stated Unequivocally, that the people at No 1, Bickern Road, were and had been intentionally Blocking the Defined Turning Area 'Every Day' Since His First and Only Visit to see me, back in Early January 2025 and that it was effectively causing Chaos, for the people/residents of Bickern Road, I also, respectfully reminded Councillor Tivnan, that when he visited me, I (Jack Connah), had informed him (Cllr Tivnan), that ***'Four (4) Disabled People and a number of other Elderly People Lived in Bickern Road and that 'Emergency Vehicles Could Not Get Access To or Turn Round in Bickern Road, with People Parking on the Very Faded Double Yellow Lines (Which I reminded Him were put there, for that Very Reason), and or without the ability to Turn Round in the Defined Turning Area'*** He (Cllr Tivnan), said/stated, that

"He would get straight on to it".

I did not 'Chase Councillor Tivnen Again by Mobile Phone' I decided, under these questionable circumstances, that I must now produce an Audit Trail of Given Promises and Undertakings, so that I had Absolute Proof of my Actions, which could be taken as pestering a Councillor, **which I Was Not!**

Lady Mayoress, I for your information, attach a resultant Audit Trail & Some of the Many Photo's that I offered to Councillor Tivnan, but he (Cllr Tivnan), for whatever reason refused sight of them, you will note that the final email from Cllr Tivnan (17/6/2025, having Chased/Written To Him Yet Again, the Torpoint Town Councillor stated (In-Writing), that 'I Quote His Written Given Word:

"I will follow this up with another email to you tomorrow"


Sadly Madam Mayoress, Councillor Tivnan, **did not** and I haven't heard from him, or anyone else regarding the Illegal Parking in the Defined Adopted Turning Area in Bickern Road, and or the Illegal Parking on the Extremely Faded Double Yellow Lines at the End (The Junction with Moor View), which have caused My Neighbours and I, great angst and have left both Me & My Neighbours Unable to Turn-Around, within the Defined Turning Area in Bickern Road, as the Caradon & Cornwall Council Highways Department Had Intended, or Get Out of Bickern Road or Into Bickern Road, because of Illegally Parked Vehicles, despite the intent of both Torpoint Town Council & Cornwall Council, when the TRO & The Poor Paint Job carried out in 2017 by Highways Department of Cornwall Council.

Thanks to the written response of Councillor Tivnan BEM dated 10th of June 2025 (16:8), I am/I became aware, that both You (Madam Mayoress), and Councillor Robert Parsonage (The Cornwall Council Councillor for Torpoint), were made aware of My Plight & That of the Other Disabled & Elderly Residents of Bickern Road (A Copy of Cllr Tivnan's Email is attached, within the Audit Trail of Documents, to which I referred earlier), but sadly despite Councillor Tivnan Effectively 'Falling Upon His Sword' (Within His email of 10/6/2025) Nothing has Moved Forward, or Has Lawfully & Appropriately Been Resolved, in-fact Nothing Whatsoever, has Happened, I respectfully request that both You (As Lady Mayoress) & Cornwall Councillor Robert Parsonage, become personally involved to resolve these obvious oversights and failings.

I can only say that I have failed you, failed myself, Torpoint Town Council and Cornwall Council abysmally.

In mitigation I did contact Highways and request that the Road Safety Steward on his next visit to Torpoint examine the current yellow lines to see if they required repainting but going by the state of some of the others around Torpoint there are various sites also with a similar need, furthermore I cannot recall receiving a response to that request.

I did not approach anyone as regards extending those yellow lines as this would require to be undertaken following a further TRO (Traffic Regulatory Order) being submitted which I do not think would be acceptable for the cost(s) involved.

As you can see I have included in my response the current County Councillor for Torpoint, the Town Mayor and also the Town Clerk, publicly showing my failings on this and possible action by them, there is nothing more that I can say.

Thank-You so much for the lovely Christmas Card and your kind response, I am hopeful that you will be able to Pop Round sometime over the Christmas period for a Tipple and a Mince Pie, to actually meet-up face to face, you probably aren't aware but the Whole of Bickern Road supported Freda, who lived there before you for many years, particularly, Rachael and Ray, who live next to both You and I, as did Tony and Sue, who live diagonally opposite your top gate, as did I before I couldn't manage your access steps anymore, after the NHS Trashed Me some Years Ago.

If You need help of any kind, all you have to do, is ask, we are a multi qualified bunch, of mainly retired people, apart from Ray and Rachael (I've got underpants older than them Ha Ha Ha), I noted your comments regarding the Bickern Road Turning Area, but I regret you are being misled by the Land Registry Plan somewhat, to assist you I drew-down the Cornwall Council Planning, Architects & Highways Department Map, which shows, the boundaries of each Property and which Roads are Adopted Roadways (Shown in White), and the Shaded Roads, are the Unadopted Roads (Like your back lane) that also leads to Rachael & Ray's front gate.

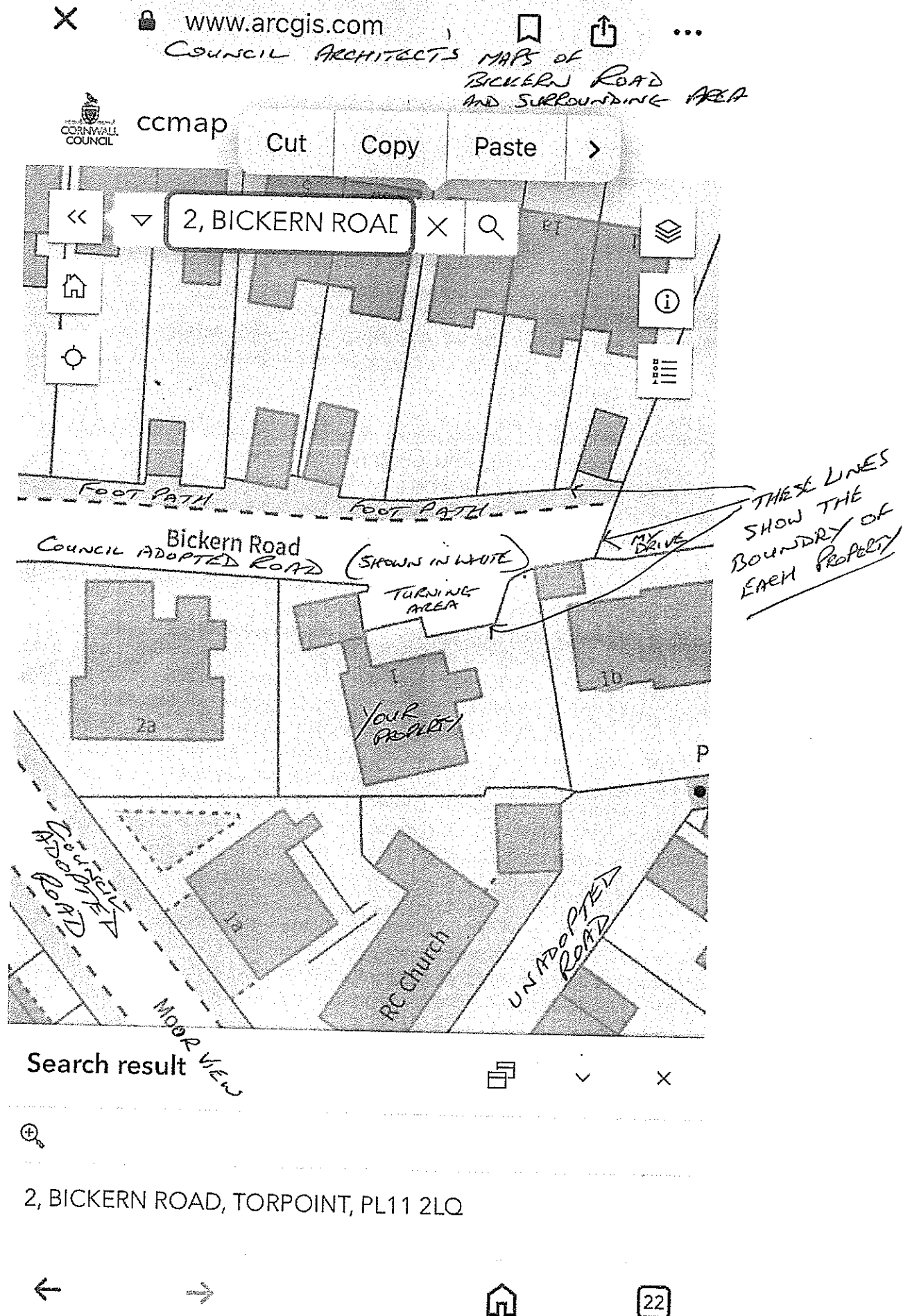

anyone.

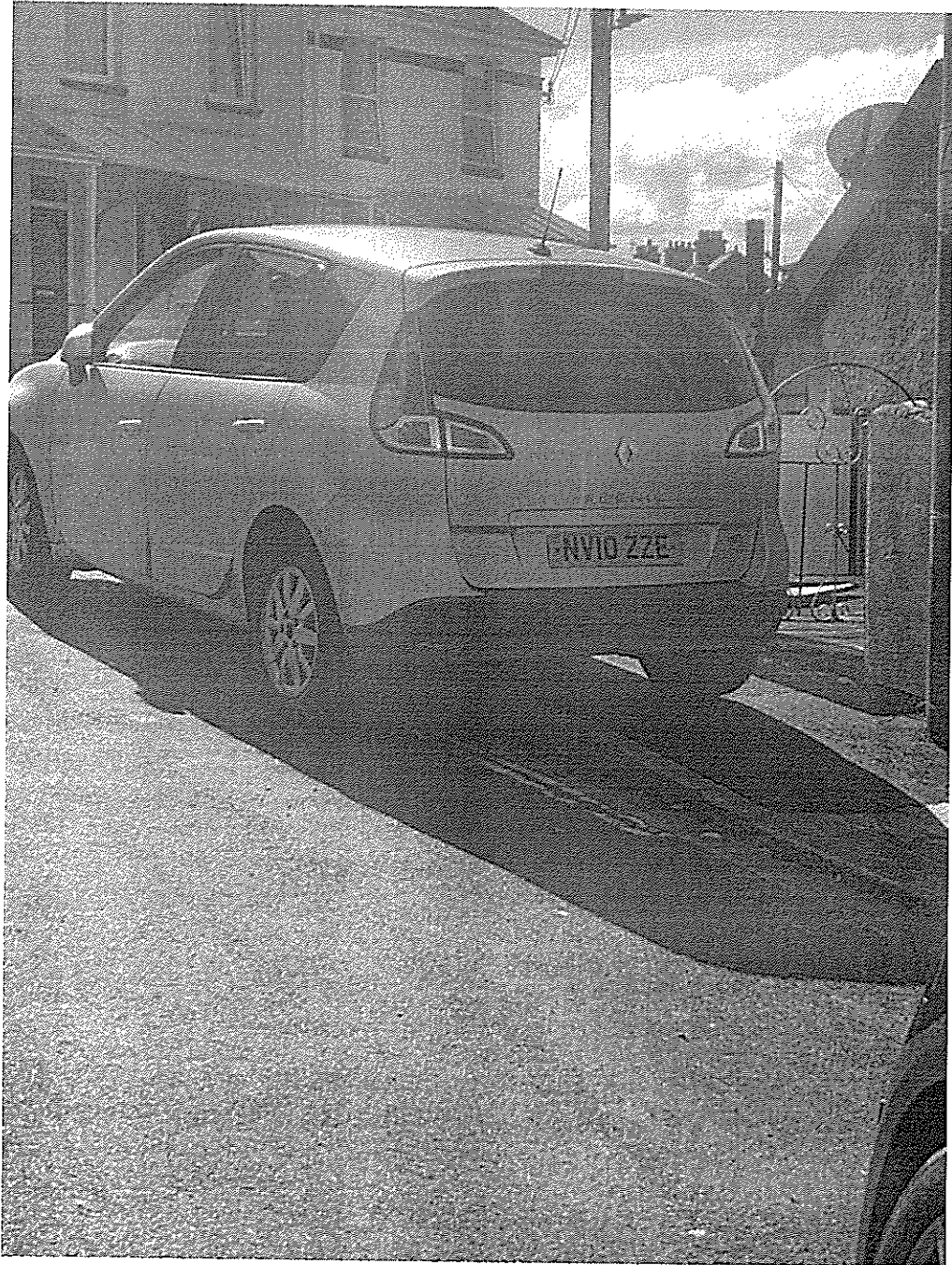

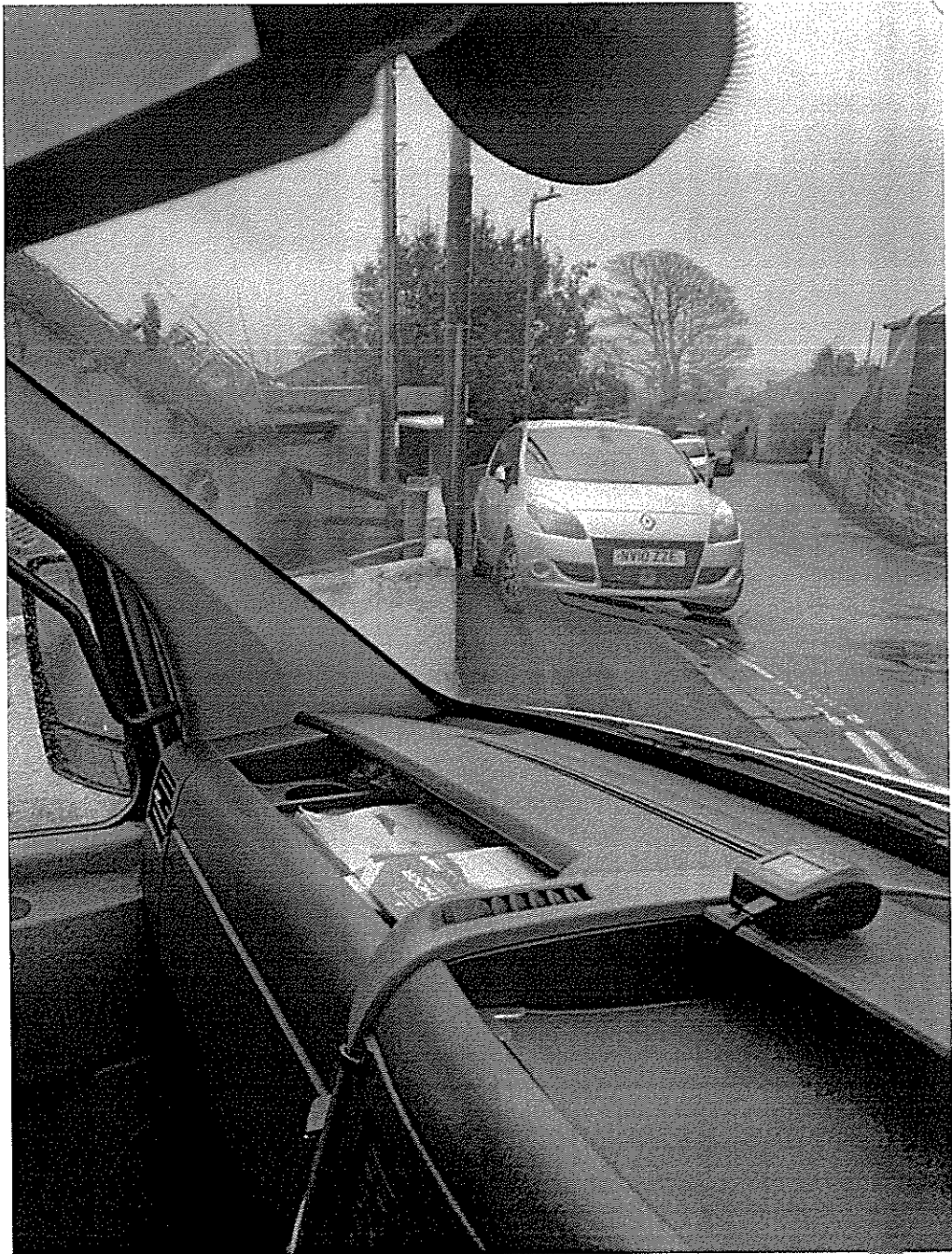

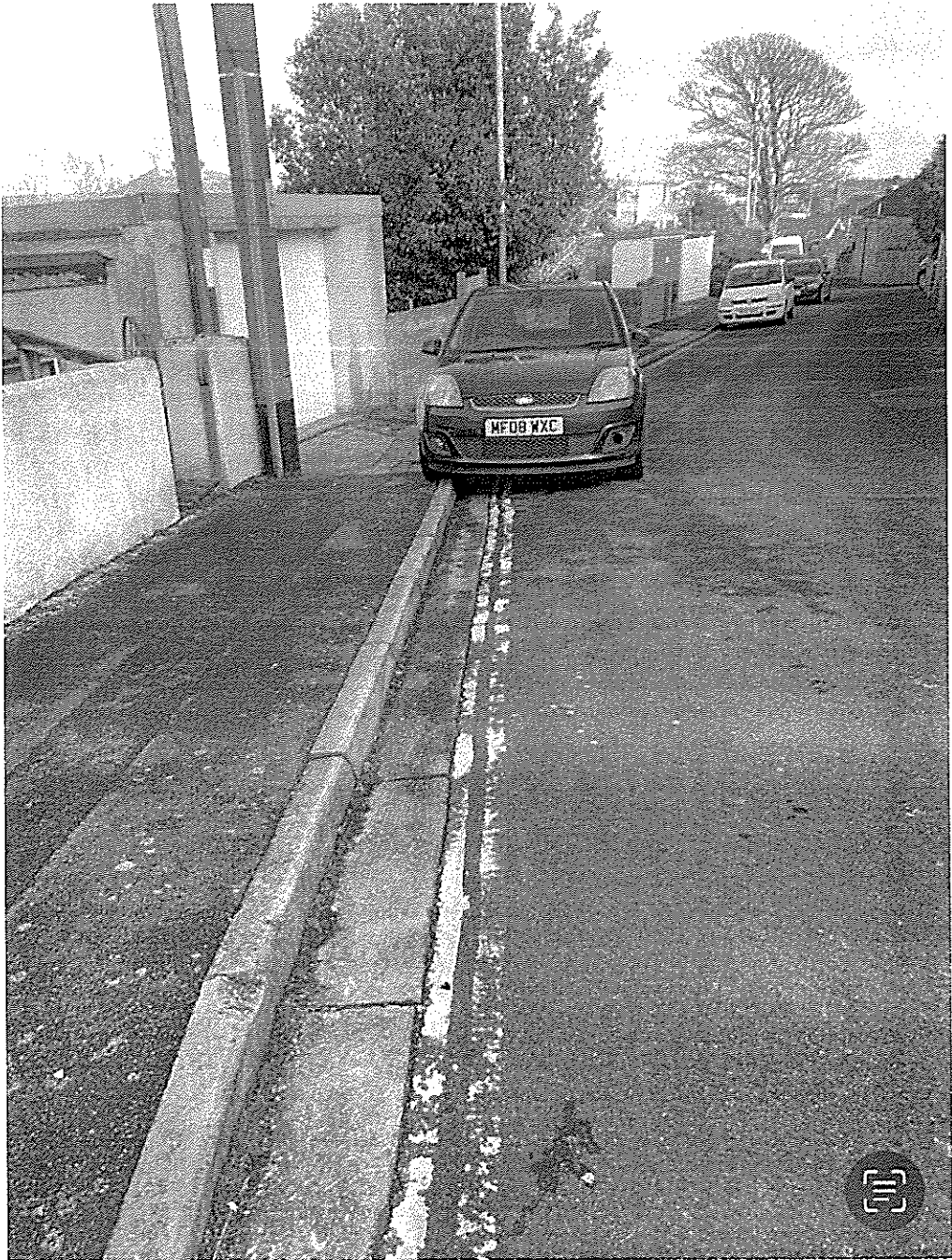
