Please tell us about the project and why you think it should receive the contribution from Torpoint Town Council

Cornwall Air Ambulance provides life-saving emergency medical services across Cornwall and the Isles of Scilly. In 2024, we responded to 1,064 missions, including 82 paediatric emergencies, 274 cardiac arrests, and 445 trauma incidents. Our extended operational hours—now up to 19 hours daily—reflect the growing demand for rapid response and critical care in a region defined by its rural and coastal geography.

To continue delivering this essential service, we urgently seek funding to support:

- Recruitment of additional clinicians
- Expansion of training facilities
- Creation of rest areas to comply with night operation regulations

Cornwall's geography presents unique challenges: remote communities, limited access to specialist hospitals, and difficult terrain. Our air ambulance service bridges these gaps, ensuring timely access to advanced medical care.

In 2024, our missions included:

- 327 medical emergencies (e.g. strokes)
- 18 inter-hospital transfers
- Critical transfers to specialist centres such as Derriford Hospital, Bristol Royal Hospital for Children, Morriston Hospital, and Salisbury District Hospital
- Emergency transfers from the Isles of Scilly to the mainland

With extended hours of operation, our crew now works late into the night, requiring enhanced support infrastructure to maintain safety, wellbeing, and compliance with aviation and medical regulations.

## Funding Requirements

We are seeking £1,000 to support the following:

- 1. Clinician Recruitment
- a. Hiring additional doctors to meet increased demand
- b. Ensuring adequate coverage for night operations
- 2. Training Facility Expansion
- a. Upgrading simulation and classroom spaces
- b. Investing in advanced medical and aviation training tools
- 3. Crew Rest Areas
- a. Developing rest and recovery spaces for night-shift personnel
- b. Supporting mental and physical wellbeing of our team

# Who will benefit from the project and how many of those are residents of Torpoint parish?

Cornwall Air Ambulance's expanded operations will benefit:

- Residents across Cornwall and the Isles of Scilly, especially those in rural and coastal areas with limited access to emergency care.
- Children and families, as shown by the 82 paediatric emergencies we responded to in 2024.
- Patients requiring specialist treatment, including transfers to hospitals in Plymouth, Bristol, Swansea, and Salisbury.
- Emergency responders, through improved training and support infrastructure.

In 2024, Cornwall Air Ambulance responded to 1,064 missions, including 82 paediatric emergencies. Of these, 9 missions directly supported people in Torpoint and Millbrook, demonstrating the importance of our service to this local community.

One particularly tragic incident occurred at **Wacker Quay**, where our crew was deployed as part of a multi-agency response to assist a family whose children became stuck in the mud while playing near the water during a BBQ. Despite the best efforts of our team and other emergency services, the outcome was not what we would wish for.

This heartbreaking event is a stark reminder that we never know what each day will bring when the emergency phone rings. It's why we must be ready for every eventuality—with the right people, facilities, and support systems in place.
