**The Enclosed 'Subject Access Request (SAR) Disclosure Request' Made of Torpoint Town Council:
Regarding 'Faded Double Yellow Lines' & 'People illegally parking in the Designated Turning Area':**

Madam Mayoress (Councillor Martin),

I first of all, apologise, for the delay, in responding to Your/Torpoint Town Council's Email, sent by Mrs Southworth (8/1/2026), on your behalf, following its receipt and having established that the content of this email, fell far short of the lawful requests, made within my hard copy written communication of the 5th Instant & A Further Email from Mrs Southworth dated the 20th Instant. Before responding further, I on behalf of the residents of Bickern Road, took advice and received directions, to that end I (Jack Connah), once again, respectfully respond and do so, as directed:

Further to the content of my last communication (5/1/2026, copy enclosed for information), I once again contact you (Lady Mayoress), personally, because, the email response from the Town Clerk (Mrs Southworth), sent on behalf of the Town Council & Therefore by implication, on your behalf, fell far short of the lawful requests made, not only throughout my written and verbal approaches to the Lady Mayoress of Torpoint Town Council and by implication therefore, made to the Torpoint Town Council itself and also, the many approaches (Due to the gravity and extent of those communications), made on behalf of my neighbours in Bickern Road, that I, appropriately and lawfully made to the (Then) Torpoint Town & Cornwall Councillor John Tivnan (BEM) from 5/1/2025 to Current, and those that I then sent and served upon the New Cornwall Councillor (Robert Parsonage) 20/5/2025 to Current, following him, replacing Councillor Tivnan on the 1/5/2025, as the New in Post Cornwall Councillor for Torpoint.

I note, what Mrs Southworth stated, within both of her recent email's sent on your behalf (Lady Mayoress), and therefore sent on behalf of 'Full Council' following the most recent Full Torpoint Town Council Meeting of the 15th Instant, sadly, as I am sure, you (Lady Mayoress), are fully aware, the response fell far short, of the lawful and under these circumstances, appropriate requests, made on behalf of the Tax-Payers & Residents of Bickern Road.

I (Jack Connah), have been directed to 'Ask of You (Lady Mayoress), of the Full Torpoint Town Council, and therefore, of Cornwall Councillor Robert Parsonage' Because sadly Cllr Tivnan, achieved absolutely nothing on our behalf, then his replacement as Cornwall Councillor (Councillor Robert Parsonage), had to be pressed, to even start to communicate, and when he finally did, he did so, only by way of email, within which Councillor Parsonage, initially informed me:

"What good work, both he and His Reform Party were doing at and within Cornwall Council and within 'Full Cornwall Council' Meetings":

Then and following the Full Torpoint Town Council Meeting of the 21st August 2025, which I (Jack Connah) Attended, at which, Cllr Tivnan came to speak briefly with me but, sadly Councillor Parsonage failed to do so, I then chased Councillor Parsonage, I was even told by Mrs Southworth, on the Torpoint Town Council's Behalf and therefore on your behalf (Lady Mayoress), that Councillor Parsonage had been asked to come to see me at my home, sadly, he never did and has never done so, to this very day:

I (Jack Connah), therefore, had no other option, but to press Councillor Parsonage to do so, by way of emails, sent by my only method of contact, with our 'Elected Cornwall Councillor' Via his Cornwall Council Email Address, as his home address (Locally), is being, for whatever reason, intentionally withheld, from the electorate, I also informed Torpoint Town Council (In writing hard copy), my reason for doing so, the only response that was forthcoming, was another email from Councillor Robert Parsonage, within which, he did not address, any of the issues being experienced by myself and my fellow Bickern Road Residents, within his emailed response, once again, he (Councillor Parsonage), only informed me and my fellow Bickern Road 'Long Suffering' Residents, that:

"He was doing great work, at and within Cornwall Council and that he would come to see me and intended to do so, the following week":

Sadly Lady Mayoress, as you will no-doubt be fully aware **'Just Like Tomorrow' The Following Week Never Arrives** Lady Mayoress and **Has Never Resulted in a Home Visit by Our Elected Cornwall Councillor** (Robert Parsonage), as a result, I (Jack Connah), have been directed to:

'Ask of You' (Lady Mayoress), and ask of the Full Torpoint Town Council, and therefore, ask of Cornwall Councillor Robert Parsonage:

"Why You & Your Many Councillor Colleagues, having asked the Devon & Cornwall Police (Local) Officers, to contact Cornwall Council's Traffic Enforcement Team 'Regarding the Two (2) Issues Complained Of' & Then You (Lady Mayoress), following the Full Torpoint Town Council Meeting of the 15th Instant , directed the Town Clerk (Mrs Southworth), to inform Me (Jack Connah), that a Cornwall Council Traffic Enforcement Officer, was to visit and assess the situation, on the (Purportedly on the 8th or 9th/1/2026), effectively, on the Day After Storm Goretti (On the 8th-9th/1/2026) Hit Torpoint & Wider Cornwall Peninsula, within which Mrs Southworth, did state that the visit may be delayed by a few days, because of Storm Goretti:

On behalf of my fellow residents, I have been asked to ask 'Why' That Cornwall Council Traffic Enforcement Officer 'Didn't (As He, or She Clearly Didn't), bother to, either communicate with, or visit the person (The complainant: Jack Connah), in Bickern Road, acting on behalf of 'All But One' Of the Residents of Bickern Road, when they (He or She), came and inspected the Faded Double Yellow Lines at the End of Bickern Road, at the Junction to Moor View:

They (He or She), intentionally 'Didn't Walk Down Bickern Road' (To See Me), and or, in order for Him or Her 'To Both View & Therefore Make a Resultant Lawful Traffic Enforcement Decision' Regarding the Residents of Number One (No: 1) Bickern Road 'Parking Two Cars-In a Designated Turning Area of Bickern Road' That 'Has Been a Designated Turning Area' Lady Mayoress 'Since Bickern Road was Adopted' By the (Then) Council 'Over Sixty (60) YEARS Ago' You (Lady Mayoress), and the (Then) Torpoint Town & Cornwall Councillor (Councillor John Tivnan BEM), were both Sent and Provided With, copies of:

***'The Cornwall Council Maps & Drawing Pertaining To Bickern Road & Its Designated Turning Area':
(Giving Proof, should proof, after this length of time, still be needed) That:***

The New Residents of No: 1 Bickern Road, have not only been Parking Inappropriately & Unlawfully, in the Designated Turning Area, for Well-Over Twelve (12) Months (From the 19/11/2024 to Current & Ongoing), despite the Designated Turning Area, clearly having been, in its own right, within a Council Adopted Road & Therefore it is, clearly a Designated Adopted Turning Area, and that also, by so doing, they(The Residents of No: 1, Bickern Road), are and you are (Torpoint Town & Cornwall Council), are:

Intentionally Putting the Health, Safety, Wellbeing & Finances of 'All of the Other Residents' Of Bickern Road, at 'Very Real Risk' As well as intentionally 'Denying Them Safe & Appropriate Access' For & By 'Emergency Vehicles' (Such As Fire, Ambulance & Police), and or 'Lawful & Safe Access for anyone else (Such a GP's & Medical Professionals, along with Service Providers 'Water, Gas & Electricity' & Multiple Business Representatives, and or Any Visitors, including Family Members), thereby Denying Them the lawful right, to Safely Turn in a Narrow Road, with Car's 'Lawfully Parked' Right Down 'One Side of the Narrow Adopted Road' Situated to the Rear & Outside of Their Own Properties, the majority of whom (As I have already made, the Police, the Town Council & All of the Councillors Concerned, within Torpoint 'Fully Aware' Of this, clearly unacceptable and unlawful 'As Yet Unaddressed' Situation), the majority of whom, like me (Jack Connah), are Elderly, Infirm & Disabled:

Nevertheless and despite this Lady Mayoress, you, your fellow Town and Cornwall Councillors, have singularly failed to rise to the occasion and have failed, by implication, to do your duty on behalf of the Tax-Payers & (All but One Household), the Residents of Bickern Road".

With this in mind, I (Jack Connah), respectfully request and I do so, on behalf of the majority of the residents (Excluding the Residents of No: 1 Bickern Road), that a request be made, by you (Lady Mayoress) on behalf of the Full Town Council that 'The Traffic Enforcement Section, at and within Cornwall Council, that they (Enforcement) return to Torpoint & Bickern Road and Appropriately Complete the Task **they were and had been given** and 'Carry-Out the Appropriate Enforcement Measures to Stop the Inappropriate & Unlawful Parking, taking place, in the Council's Own Adopted & Designated Turning Area' & Do So Lady Mayoress, within the next Seven (7) Working Days.

Because of the unusual and questionable, soft shoe shuffling of Torpoint Town Council and of a number of Torpoint Town & Cornwall Councillors 'Public Servants' That has undoubtedly occurred from 5th of January 2025 to current and sadly ongoing, **I am directed to submit a Subject Access Request (SAR) Disclosure Request to Torpoint Town Council**, to obtain 'Copies of All of the Internal Records, communications, emails, notes and minutes of meetings (Including the discussions that took place in Full Torpoint Town Council Meetings, pertaining to lawful requests, made of Torpoint Town Council and of both, the Past & Present Cornwall Councillor's for Torpoint (Tivnan & Parsonage), regarding both the Faded Double Yellow Lines & The Inappropriate and unlawful Parking taking place, in a 'Council Adopted Designated Turning Area in Bickern Road' Including any interactions regarding the Issues that took place, with the Cornwall Council's Parking Enforcement Team/Section (Made Both To & From).

This situation has only arisen Lady Mayoress, due to the multiple failures, that have undoubtedly occurred, for whatever reason, over the last Twelve (12) Months at and within Torpoint Town Council and the ongoing failures of Two (2) Cornwall Councillors, I (Jack Connah), on behalf of my fellow residents, have no other option but to request the Subject Access Request (SAR) Disclosure Request, which needs to be released, as you and Mrs Southworth are no-doubt aware, within the Twenty (20) Day Period, allowed by and compliant to, current ICO, HM Government & Council (Local Authority) Disclosure Protocols:

Which requires those Council Internal Records (Lock, Stock & Barrel), to be released in chronological order, numbered and unfettered by any redactions, therefore in full, with: 'No Exceptions' Other than those, that are protected within and by 'Data Protection Rules, Regulations & Statute'.

Please revert personally Lady Mayoress.
